٢,١٢. Accounts connected to copy trading will be blacklisted .

٢,١٣. PAMM accounts are acceptable for connection, but their balances should not fluctuate significantly to avoid issues for the bot .

٢,١٤. If, during the bot's operation, more than ١٠% of the capital is withdrawn without prior coordination with the site and the bot's settings are altered, the client assumes full responsibility for any losses incurred .
